In 2021 there were 133,444 snowmobiles sold worldwide; 59,234 were sold in the U.S. and 50, 567 were sold in Canada.

There are over 1.3 million registered snowmobiles in the US and over 596,000 registered snowmobiles in Canada.

In the US Snowbelt lineup, Wisconsin ranked 1st for the numbers of registered snowmobiles and Montana is 8th on the list.

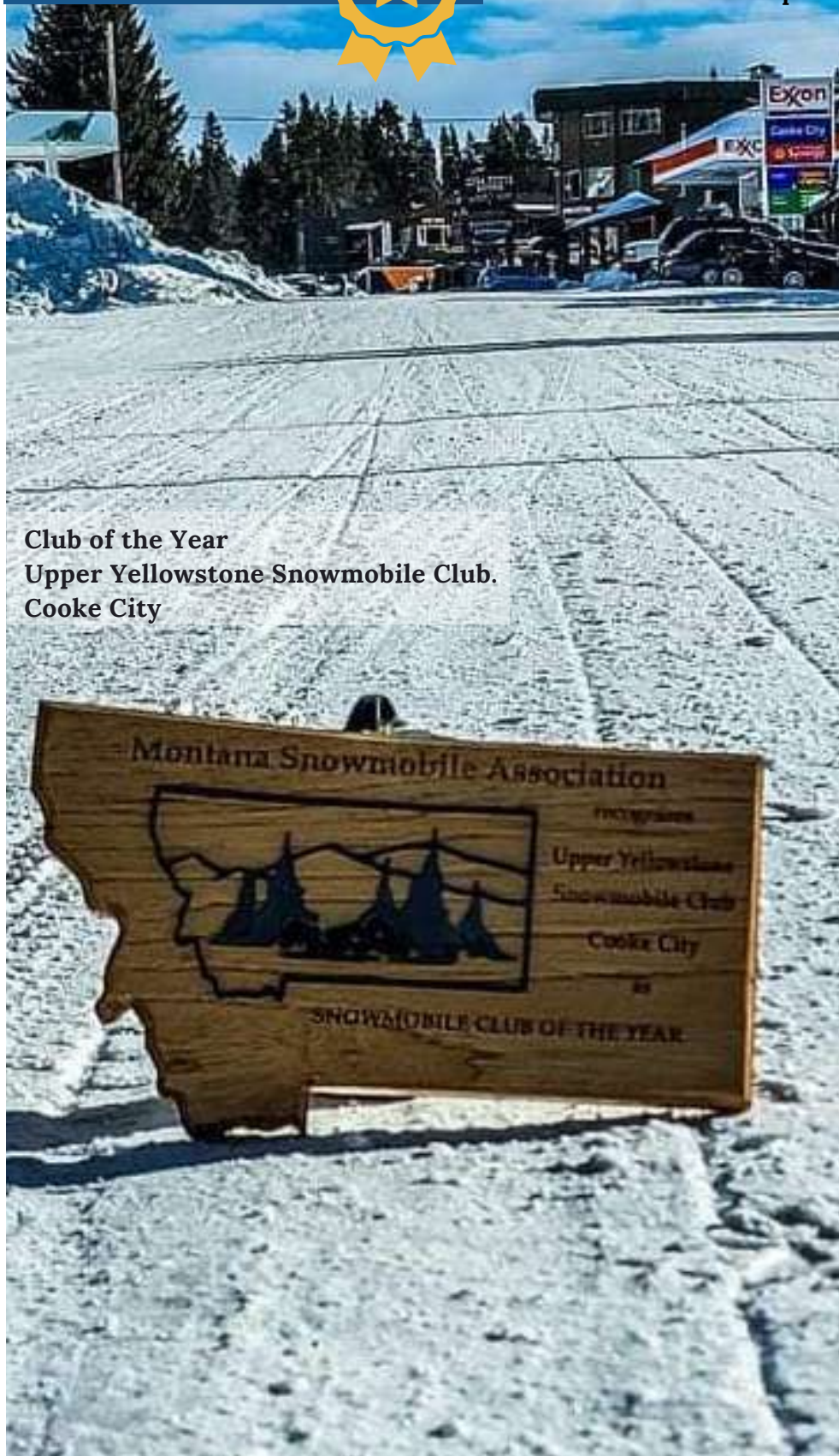

# West Yellowstone Two Tops Trail Loop

## Trail Pass Reciprocity Coverage

Idaho and Montana State Law requires snowmobile registrations on all snowmobiles. However, there is some money-saving good news for riders heading to Two Top on the trail system.

The Two Top trail 30-mile loop starts and ends in West Yellowstone. The Hebgen Lake Ranger District and Ashton/Island Park Ranger District in MT/ID have agreed to offer reciprocity covering the loop trail system for the short pass-through in and out of Idaho. The ID Nonresident permit is not required to ride the Two Top trail. Anyone leaving the Two Top Trail into Idaho is required to purchase the Nonresident permit.

# Beyond the Beacon

## Thoughts and gear for a safe backcountry experience

Accidents happen, but they had not happened to me in any significant way. While I do not feel youthfully invincible, I have a confidence built from many years working as a professional rescuer in the mountains. But there I was on January 4th, 2022, sitting in the snow with a dislocated shoulder. I was unable to reduce it and the pain severely limited movement and hampered any ability to ride or self-rescue. Here is some of the gear, training and thought processes that stacked the chips in our favor.

At the avalanche center, we emphasize that every member of your group should have a beacon, shovel and probe along with the training to utilize them efficiently in case of an avalanche. However, many backcountry incidents don't involve avalanches and even minor injuries can quickly complicate a simple day of mountain travel. After my accident, walking or riding a snowmobile was a challenge, and painkillers and a couple of triangle bandages were invaluable resources. Always carry a good first aid kit that is light and includes supplies to address life-threatening emergencies and stabilize common injuries. A Wilderness First Aid or Wilderness First Responder class prepares you to put this gear to work.

Do not forget the fundamentals of your medical training. Sick and injured patients get cold easily and getting cold exacerbates everything. After my accident, puffy expedition mittens with hand warmers went on and a giant down coat went over everything I was already wearing. Mugs of hot cider provided simple sugars to stoke the internal fire and an external bonfire made from green wood roared to life when a flare (along with a bit of gasoline) was thrown into the mix.

A tarp suspended by parachute cord kept the wind off and served as an emergency toboggan to help move me into the flats. Many of these items had been in our emergency kits for years without being used but were effectively employed during the rescue. None of these supplies would have made for a comfortable night out, but it would have been survivable if we had not been able to evacuate that afternoon.

Our proficiency and desire for self-sufficiency in the mountains could have led us to not call for backup. I certainly did not want to get rescued and we openly asked, "How can we get ourselves out of here." Wisely, we activated local search and rescue in part because we were in fact riding with several members of the Fremont County Idaho Search and Rescue Team at the time. We need confidence to successfully navigate through the mountains and we need humility to know when to ask for help. An organized rescue takes time to mobilize and arrive, and if you can sort out your own emergency they can be turned around. Calling them early facilitated a timely evacuation and minimized the chances that we would have had to spend the night in the backcountry.

Ultimately, I am lucky to be on the road to healing and have every intention of being back in the mountains soon. Integrate some of these lessons into your backcountry travel plans and we hope the gear and the training will be a backup you never have to use. Finally, thank you to the members of the Fremont County Idaho Search and Rescue Team specifically and search and rescue volunteers in general. We are lucky that you have our backs.

If you have not taken one recently, please reconsider. While you are out this summer, practice with your transceivers to hone your skills. Your family and friend's life may depend on it.

I ask those of you who are not members of a snowmobile club or have let your membership lapse, to reconsider joining with us to share your talents and abilities with your local club. Help them strengthen your communities. These efforts better our membership and benefit Montanans everywhere. The snowmobile clubs are the foundation of our successful grooming program.

The FWP director did a ride-along of a different sort and happily hitched a ride in the new snow groomer.

Everyone wants to ride on the best trails possible and Montana's programs are no exception and getting better each year with the amazing support we have from local clubs, numerous volunteers, supportive landowners, government programs and agencies."

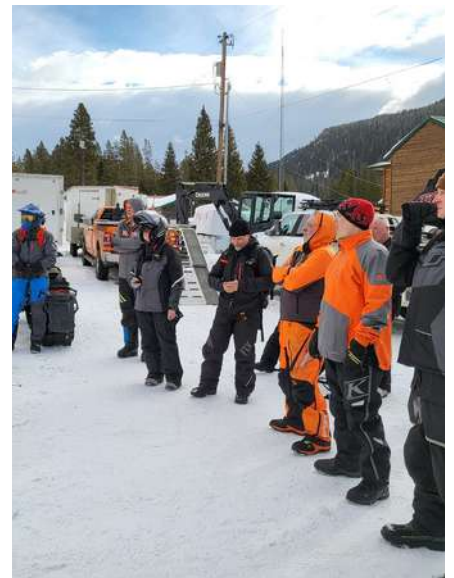

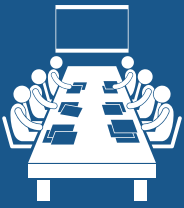

# Defending Back Country Riding

## HR1755 Northern Rockies Ecosystem Protection Act

As our sledding season winds down, we ask members to keep an eye out on Bill HR 1755. This bill would convert all inventoried roadless systems to wilderness.

House bill HR1755, Northern Rockies Ecosystem Act, would convert approx. 23,000,000 acres (yes, that ni of Inventoried Roadless Areas (IRA) in the western states into the National Wilderness System. No public comment, just a decision by members of Congress based on input from wilderness activist groups. Their “omnipotent powers” apparently know what is best for us whether we like it or not.

Montana has 6,397 acres of IRA on National Forest lands. When you look at the proposed areas to be converted, this bill covers a wide swath of those 6,397 acres. I don't have to remind you that a WILDERNESS designation means NO MOTORIZED OR MECHANIZED access. This bill will usurp Any RWA or WSA that is currently open to motorized and mechanized access through Forest Travel Planning and prohibit that access.

Bill HR1755 was recently scheduled before the Federal Lands subcommittee, however, it was subsequently tabled. No reason was given but we suspect it was because of opposition by several multiple-use groups including Backcountry Sled Patriots. That was the good news. The bad news is there is a reasonable expectation it will be rescheduled in the next month or two. The current administration really wants to see this bill pass before the mid-term elections.

The potential for this bill to pass is frightening. If it gets through the Federal Lands subcommittee, it goes to the House and then to the Senate for a full vote. It only needs a simple majority to pass either chamber. The real wild card is there are Republican members of Congress from the East that think wilderness is a good thing as long as it isn't in their back yard. The best offense we can garner is to deliver a full-court press of opposition to the Federal Lands subcommittee. Rep Russ Fulcher (Id) is the ranking member on that committee so we do have a solid conduit to present our views and comments. The only caveat is: you need to send them to him! Talking about it in the coffee shop won't cut it.

When you send comments note that these comments are for case file reference if HR 1755 gets rescheduled. The more comments Fulcher's office gets now the more leverage he has to keep any potential future hearing squashed.

Obviously, these IRA lands are lands we recreate on, however, there are also other concerns. By law, fire suppression in designated wilderness areas is very limited and generally left to nature until it gets outside a wilderness boundary. Imagine the consequence of another 23,000,000 million acres in the west subjected to this form of limited fire management. Once a designated wilderness is created the economic impact on small communities can be severe due to vastly reduced recreation visits. Snowmobiling is a big economic driver in Montana. Shutting down the opportunity for backcountry riding and consolidating riding areas to a limited trail system is asking for more user conflicts. And don't think for a moment if HR1755 were to get passed the current trail systems won't be the next target for NON-MOTORIZED ACCESS.

### IF YOU SIT ON THE FENCE YOU MIGHT BE LIMITED TO RIDING IN THE BACK 40 PASTURE.

The list of proposed acreage to be converted to wilderness areas can be found online. Google HR1755 to see the whole list. I would bet money everyone reading this has ridden in one or more of the areas listed. Your engagement is the only path forward to keep these areas open. Rep Fulcher can't successfully argue before the subcommittee what he “thinks” or offer just his personal opinion. He needs your supporting input to back up his position. I urge all presidents of snowmobile clubs to work hard to get your full membership, and even non-members, involved. There won't be a second chance!
